

# Dog Walking/Pet Sitting & Transportation Authorization

## **Page 1 – Dog Walking/Pet Sitting & Transportation Authorization**

- 1) I understand that Paws in Paradise reserves the right to deny service to any pet that they feel may be harmful to their staff and/or other pets in their facility. This includes, but is not limited to being aggressive, anti-social, overly active, overly anxious, or physically ill.
- 2) **RABIES** – I attest that my pet(s) is fully vaccinated against rabies. I will also provide Paws in Paradise with a vaccination certificate(s) verifying the update of these vaccinations. If I cannot provide verification, or provide fabricated records, I will take responsibility for any medical bills that the facility may incur for my pet injuring any staff member and any other fees that may occur.
- 3) **Dog License** – I attest that my pet(s) are registered with the city of New York and if they are to be walked, I will provide updated license tags and rabies tags on my dog's harness/collar. If the tags are not attached, and a ticket is issued, it is my sole responsibility to reimburse Paws in Paradise for the amount of the ticket.
- 4) **Suitable Supplies** – I acknowledge that I am responsible for providing suitable harness/collars/leads as approved by a Paws in Paradise Walker at the time of the visit. In the event that no such equipment is provided upon pick-up or if the equipment is deemed unsafe for use, Paws in Paradise will deny services with all charges still applied.
- 5) **Flea and Tick** – I attest that my dog(s) is using flea/tick protection and does not have fleas and ticks. I will not hold Paws in Paradise accountable for any fleas/ticks that are found on my pet.
- 6) **Emergency Care** – I acknowledge that Paws in Paradise will notify me of any emergency immediately. But if, in my absence, my pet should become injured or ill or it is otherwise deemed by Paws in Paradise that immediate veterinary assistance is required; I authorize Paws in Paradise to contact and take my pet to the most available certified veterinarian, or take my pet to the nearest animal hospital for treatment. I also acknowledge that I am responsible for all charges with respect to such veterinary care.
- 7) **Bonding** – I understand that Paws in Paradise's walkers/sitters are bonded and fully insured, but Paws in Paradise accepts no liability for any breach of security, loss, or damage to the client's property if any other person unlawfully accesses the premises. Doors will be double-checked that they are locked before walker/sitter leaves the premise. Paws in Paradise will not be liable for any occurrence that may happen while the pet is not in the supervision of a Paws in Paradise's walker/sitter.
- 8) **Keys** – I will provide Paws in Paradise with 2 sets of keys, remote entry devices necessary for entry either for pickup my pet for walking or pet sitting. Paws in Paradise and its walker/sitter shall keep all objects confidential and under no circumstance unlawfully reveal any of said information to a third party unless warranted by law.
- 9) **Holidays** – I acknowledge that Paws in Paradise guarantees year-round services except on acknowledged holidays: New Years, July 4<sup>th</sup>, Thanksgiving, and Christmas, and when Paws in Paradise deems the weather to be potentially hazardous to their walkers/sitters, or your pet.

10) **Cancellations** – I understand that cancellations for any AM walks or pet sitting must be made no later than the prior night during opening hours. For any PM walks or pet sitting I must cancel no later than 9am that same day. If a cancellation is not made within the appropriate time, I understand that I will be charged for that walk/sitting.

11) **Walker/Sitter Consistency** – I acknowledge that Paws in Paradise will try to accommodate by using the same walker/sitter to care my pet on a routine basis, but reserve the right to switch walkers/sitters if it becomes necessary, such as in the event of illness, shift switches, etc.

12) **Emergency Walk/Sitting** – I acknowledge that Paws in Paradise will charge an additional fee for an emergency walk or sitting. An emergency walk/sitting is any unscheduled service scheduled for same day.

13) **Services** – I acknowledge that Paws in Paradise walkers/sitter will only perform the agreed upon services stated at the initial meet and greet. Any changes must be in writing and confirmed by Paws in Paradise at least a day before the service.

14) **Cleaning Defecation** – I understand that Paws in Paradise and their walkers/sitters will be responsible in cleaning after my pet’s defecation from all public areas. However, Paws in Paradise walkers/sitters are not responsible for any urination or defecation within my home that occurs after they have left the premises.

15) **Credit Cards** – I acknowledge that leaving my credit card on file will allow Paws in Paradise to charge for services rendered. Paws in Paradise and their staff shall keep all information confidential and under no circumstance unlawfully reveal any of said information to a third party unless warranted by law.

16) **Refunds** – I understand that packages are non-refundable.

17) **Agreement** – I certify that I am the owner of the dog(s) and I am authorized to make decisions about my dog(s). By signing below, all terms and conditions of this agreement thereof shall be binding between the owner of the pet(s) stated on the enrollment form and Paws in Paradise for all services performed today and in the future.
